Statutory and regulatory references are included, as appropriate, and should be reviewed carefully to ensure that schools are meeting all requirements. **New requirements beginning with the 2022-23 school year are highlighted in yellow**.

Schools and districts should also reference the <u>Illinois Graduation Requirements Document</u>, which provides guidance on state-required courses and compulsory units of study in which students must earn credit for conferral of a high school diploma.
